

9. **Nature of Duties:** Operation and Maintenance of broadcast equipment audio Work Stations, switching and transmission console, VTR, Vision Mixer, CCU Audio Console, Video/ Audio Streaming & IT Equipment, OB/ DSNG, UPS, LT/ HT Switch Gear DG Set of Akashvani/ Doordarshan Studio/ Transmitter/ Earth Station etc. or any other equipment installed in the TV studio and PCR, in shift duty. May also be required to work in other technical areas such as Broadcast IT/Post Production (NLEs) maintenance/OB / MCU etc. depending upon the requirement of the work.
