Essential Educational Qualifications: Graduate in Engineering with minimum 60% marks or equivalent grade in the engineering.

Must have qualified GATE exam in the past 2 years (i.e. 2023 & 2024).

Desirable: A Master degree in Engineering / Post graduation in relevant discipline, with an over-all perspective of National Energy Programmes and Policies with thrust on Energy Efficiency and Energy Conservation.

Experience: A minimum one year of experience in Research / Development / Design / Academic Institutions / Government Departments / Institutes / Organizations dealing with Energy Efficiency or its conservation, and energy auditing and other related areas.

Expected Competencies:

- i. Ability to conduct research and collate background information on energy efficient technologies and best practices.
- ii. Should be able to provide technical inputs culled from various reports developed under the project (as well as external sources) for developing awareness and outreach materials such as case studies, documentaries, broachers, etc. for the benefit of project stakeholders.
