CSIR-CIMFR, intends to hold walk-in-interview for engagement of Part Time Doctor (Allopathic) in conference room of CSIR-CIMFR, Barwa Road, Dhanbad on 25.10.2024. Those candidates who are willing to appear in the walk-in-interview shall have to present applicant's form duly attested by themselves with the requisite dossiers at the time of interview. (1) Job Requirement

For Part Time Doctor: -

To perform general duties as a Medical Officer in CSIR-CIMFR, Dhanbad, Barwa Road Campus & Digwadih Campus and its units at Ranchi & Bilaspur and to attend to patients which will comprise employees, pensioners and their dependent family members and family pensioners. He/She will have to attend either the morning shift or the evening shift of OPD of CSIR-CIMFR Health Center, (Dhanbad, Ranchi & Bilaspur Unit) duration as per requirements and as decided by the Competent Authority of CIMFR. In case of serious ailments, if required, he/she has to refer patients to some of the Hospitals which are tied up with CSIR-CIMFR for extending treatment with credit facility or without credit facility, as the case may be. He/She will also have to certify the credit Hospital bills as well as credit Medicine bills received in respect of those patients referred and attended by him/her.

For Part Time Doctor

Payment of monthly honorarium for Part-time doctor is solely attendance based for the whole month and in case of absence from duty on leave or for any other reason in a month, the honorarium will be calculated on prorata basis for the period of duty, the consolidated amount of which will be paid in the 1st half of the following month. No other payment except the admissible honorarium based on actual attendance will be paid to the part time Doctor.

(2) Period of Engagement: -

Engagement of part time Doctor will be purely on contract basis for a temporary period and it will not confer any right, explicit or implicit, to the incumbent for any claim for absorption/regularization/continuation against any post of CIMFR/CSIR. The period of engagement as part time Doctor will not be extended under any circumstances after the incumbent attains the age of 70 years. However, the engagement of part time Doctor may be terminated at any time by CSIR-CIMFR by giving one-month notice without assigning any reason and the incumbent may also terminate his/her services by giving one month notice in advance, which can be extended or curtailed OR immediately by paying one month honorarium to CIMFR in lieu of the notice period.

(3) General terms & conditions for engagement of Part Time Doctor: -

- (i) No TA/DA will be paid to the candidates for joining of the assignment.
- (ii) Tax deduction at Source: Income Tax or any other tax liability will be as per the prevailing rules and it will be deducted at sources before effecting the payment of honorarium for which the office will issue TDS certificate.
- (iii) Confidentiality of data, information and documents: The information, data and documents related to the office shall remain confidential. No one shall utilize or publish or disclose to a third party, any part of the data or statistics or proceedings or information collected for the purpose of this assignment or during the course of assignment for the office, without the expressed written consent of the office. The part time doctor shall be bound to hand over the entire set of records or assignments to the office before the expiry of the contract or before.
- (iv) Conflict of interest: The Part Time Doctor engaged by this office, shall not represent or give opinion or advice to others in any matter which is adverse to the interest of this office.
- (v) Canvassing in any form and/or bringing any political influence or otherwise will be treated as a disqualification for the above position.
- (vi) The engagement of part-time doctor is subject to the terms and conditions issued by CSIR




in this regard from time to time.

- (vii) For all intent and purposes, the services of Part time doctor will be under administrative control of the Director, CSIR-CIMFR.
- (viii) The candidates applying for above position must be medically fit.
- (ix) CSIR-CIMFR reserves the right not to fill up a particular position, if it so desires. The number of vacancies indicated above may vary at the time of actual selection.

(4) Procedure for Engagement of Part-Time Doctor -

- (i) Application in prescribed format duly filled in all respects along self-attested copies with Aadhar card and all relevant mark sheets and certificates etc. should be brought at the time of walk in interview.
- (ii) Candidates shall also bring the original documents for verification before interview and the candidates whose documents will be found in order, shall be permitted to appear in interview.
- (iii) The date for determining age/qualification and experience shall be the date of Walk –in-Interview.
- (iv) Incomplete application (i.e. without photographs, relevant mark sheet and certificates and unsigned, applications received after the last date, etc.) will not be entertained and will be summarily rejected..
- (v) In case of any false information in the Annexure, the competent authority will cancel the candidature of the applicant and the candidate will be debarred from attending the interview in future.
- (vi) Permission for online interview may be given on prior request for attending interview through VC, candidate must submit their resume in prescribed format/application form to the email id racell@cimfr.nic.in with their request by 23.10.2024 the time of interview will be communicated in due course of time.
- (vii) Selected candidates must bring all original and self-attested copies of mark sheets/certificates of Educational Qualifications and Experiences etc. along with a recent passport size photographs at the time of joining. In case of failure to bring the original mark sheets/certificates, selected candidates will not be allowed to join as Part Time Doctor.

Interested eligible candidates may download and fill up the requisite information in “Annexure-A” proforma to appear in walk in interview with enclosing their bio-data along with self-attested photocopies of certificates and affixing recent passport size coloured photograph on it.
