Application in the prescribed format are invited from the intending candidates for Engagement of Guest Teachers against the following vacancies on purely contractual honorarium basis under ST & SC Department of Deogarh District.

N.B.:- 1. Preference will be given to the retired teachers having the above qualification.

2. The number of posts may increase or decrease as per requirement.

The interested candidates fulfilling the eligibility criteria as mentioned above may submit the filled-in application form as enclosed in Annexure-A along with the Xerox copies of required documents by **Regd Post / Speed Post** only. The application form along with details of this advertisement can be downloaded from the district portal www.deogarh.odisha.gov.in. The envelope containing the filled-in application form and required documents should be superscribed with "Application for the Post of Guest Teacher" and it should be addressed to the **District Welfare Office (DWO), Deogarh, Odisha, 768108**. The applications must reach to the office of the undersigned on or before **25.11.2024 5.00 PM** and any application received after the deadline shall not be considered. The candidates who do not fulfill the above mentioned eligibility criteria will not be allowed to attend the walk-in-interview even if they have submitted the applications within the deadline. No candidate shall be allowed to attend the walk-in-interview without his application being received within the deadline. If any forged document/certificate is detected, it will lead to forfeiture of the candidature.

A. Mode of Selection:

The marks will be assigned to the candidates in the following manner and on the basis of the marks secured by the candidates the merit list will be prepared.

- a. 50% career weightage (50 marks) = 1st Div- 50 marks, 2nd div with minimum 50% marks- 30 marks.
- b. 30% teaching experience (30 marks) = 1 year- 10 marks, 2 years - 20 marks, 3 years and above - 30 marks.
- c. 20% interview (20 marks).

Total= 100 marks

- d. Ten (10) months of teaching experience should be treated as a year and 10 marks will be awarded for each year of experience with maximum limitation of 30 marks. Candidates having more than 3 years of experience will be limited to 30 marks. The experience certificate must have been duly issued by an educational institution where the candidate was teaching. It should bear the issue number, date and signature with seal of the head of the educational institution.
- e. The merit list of the candidates will be prepared as per the marks secured by them out of 100 as elaborated above.
- f. If the total marks scored by two or more candidates is same, candidate with higher percentage of marks in CT or B.Ed., as the case may be, shall be given preference.
- g. The merit list shall remain valid for one (1) year.

B. Duties and Responsibilities of Guest Teacher:

- a. Teaching of concerned subject as per syllabus.
- b. Timely correction of class and home assignments, test papers, projects etc.
- c. Setting of question papers for various tests and exams.
- d. Preparation of lesson plans and maintaining academic record of students.
- e. Preparing students for curricular/ co-curricular activities etc.
- f. Performing invigilation duty/ evaluation work as and when assigned.
- g. Any other work as to be assigned by the Headmaster.

C. Term and Conditions:

- a. Guest teacher engaged would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of SSD Deptt.
- b. Working hours and period duration shall be as per the school time table.
- c. The engagement of these Guest teachers will automatically come to an end once a regular/ contractual teacher is appointed/ engaged against the vacant post or as and when the appropriate authority decides.
- d. The Guest Teacher so engaged shall also be entrusted with correction and evaluation work of the concerned subject in the school and he/ she will not be entitled for extra honorarium for such work.
- e. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non-performing or engaged in activities leading to misconduct he/she shall be disengaged by the appropriate authority under intimation to the DOW.

V. S. S.

- a. Maximum age of Guest Teacher at the time of engagement shall be Sixty Two (62) and the retired teacher engaged as Guest Teacher shall be disengaged on attaining the age of Sixty Five (65).
- f. A guest teacher remaining absent unauthorized and not taking classes for a continuous period of 15 days or more shall be deemed to be terminated and he shall never be entertained further.

D. Honorarium:

- a. A guest teacher shall take maximum of Forty (40) classes in a month.
- b. A +2 CT Guest teacher will be paid Rs. 300/- per class/period not exceeding Rs. 12000/- per month and the TGT Level/Hindi/ Sanskrit Guest Teachers shall be paid Rs.400/- per class/ period and not exceeding Rs. 16000/- per month.

The candidates are required to come to the personal interview with a filled in application in the format to be downloaded from the district portal www.deogarh.odisha.gov.in enclosed with a set of self attested copies of their certificates and mark sheets of all examinations passed and with a colour passport size photograph pasted on the front page. No application by post or by hand is required to be submitted before the above mentioned date for personal interview. The date and venue of personal interview will be intimated later on.
